## Personal data that we process

In order to provide you with healthcare it is necessary to gather information about you. This are amongst personal data and information that is necessary for your treatment. The Preventief Medisch Centrum, processes the following information of you:

- Given names and Surname
- Title of nobility and academic degrees
- Your photograph
- Gender
- Date of birth
- City of birth
- Country of birth
- Nationality
- Address information
- Phone number
- Mail address
- Partner and family
- IP-address

- Bank account
- Information through cookies
- Practitioners

### Sensitive personal data

The Preventief Medisch Centrum processes sensitive personal information, the following sensitive information is being processed of you:

- Medical records;
- Information that may disclose your religious, ideological or political views;
- Information that may disclose your sexual behaviour or sexual preferences;
- Information that may disclose your race or ethnic origin;
- Information of persons who are younger than sixteen years;
- Social Security Number / Citizen number or an equivalent of such number;
- Genetical information.

### Registration

After obtaining your personal information, PMC will store in its own database or on databases of third parties so we don't need to register again. The information that we have obtained from you will be validated and may be supplemented by the citizen database.

We won't provide identifiable personal information to third parties, unless we consider it necessary for your treatment or our healthcare provision, or when the laws requires us to do so. In case of suspicion of fraud or malversation of our services we will issue your personal details to the competent authority.

### Purpose of processing your information

With which purpose and on which basis we process your personal information:

- For providing and carrying out good healthcare;
- To create your medical file;

- Because we have a legal duty to obtain certain details of you and store those details in our database or in your medical file;
- To create your invoice;
- To process your payment;
- To be able to contact you through mail, electronic mail or phone to carry out our healthcare;
- Anonymised researches and trials;
- To deliver goods and provide additional services to you.

## Publications

We don't publish your information.

## Disclosure to third parties

We may disclose your information to third parties. Third parties are part of your treatment and our healthcare provision. If a third party requests information that concerns you, we may request a written authorization from you.

We may disclose your information to third parties in exceptional situations without your permission. We will do this only in the circumstance when we think that this is the only option (ultimum remedium) to prevent you from harming yourself or others and when we are at trouble of conscience.

## Retention period

The legalisation obligates us to store your personal information for twenty years, after the treatment agreement has been ended with us.

## View, add or adjust information

You have the right to view your personal details (including your medical file), to request a revision, add additional information and request to remove information or destroy information. Furthermore you have the right to revoke your consent for processing your personal details, the right to object against the processing of your personal details and the

right for data portability. This means that you may request to transfer your personal details to you or others.

### Request to amendment

Do you would like to request access, revision, removal or data transfer of your personal details or do you want to revoke your consent of processing your personal details or do you want complain? Please contact the secretary of the Preventief Medisch Centrum.

## Security

The Preventief Medisch Centrum B.V. takes the protection of your information serious and has taken appropriate measures to prevent abuse, loss, unauthorized access, unwanted disclosure and authorization changes to your personal details. We have taken the following measures:

- Access to your personal information is protected by usernames, password and authorization tokens;
- The personal information is saved in a separate system after receipt;
- We send your information through a security internet connection (TLS [previously known as SSL]). This can be seen at the address bar 'https' and the padlock in the address bar;

- Security software, like a virus scanner and firewall;
- Auditing logs of all the actions of the system.
